PGC HOLDS MEDICAL AND DENTAL MISSION FOR LESS FORTUNATE NAICEÑOS



PGC GRANTS WELFARE ASSISTANCE FOR THE LESS PRIVILEGED CAVITEÑOS



The Provincial Government of Cavite (PGC) thru the combined efforts of Provincial Social Welfare and Development Office (PSWDO) and Provincial Treasurer's Office (PTO) facilitated the distribution of welfare assistance to indigent residents of Cavite on January 21, 2019 at the Provincial Gymnasium in Trece Martires City.
