Firework injuries this New year celebration lessen by 35 % - DOH

The Department of Health (DOH) today reported a 35% decrease in fireworks-related injuries but cautioned the public that these numbers may still increase due to late consultation. There was no case of fireworks ingestion, stray bullet injury, and death reported.

From 21 December 2019 to 1 January 2020, 164 fireworks-related injureported last year (249 firework related injuries and 2 cases of fireworks ingestion). The number of cases this year is 71% lower (2014-2018) of 403 cases. piece of heat sealed plastic Million Pesos.

we achieve zero firework related injuries. We will build on the gains this year to ensure that the next holidays will be safer for every Filipino," Health Secretary Francisco T. Duque said. He added that those injured should immediately have their consult at the nearest health facility for proper health management and to avoid fatal complications like tetanus.
