Vaccine road map revealed by DOH and NTF

The Department of Health (DOH) and the National Taskforce on COVID-19 (NTF) revealed updates about the immunization process for the COVID-19 vaccine in a press conference held today, November 9. Present in the virtual presser were Health Secretary Francisco T. Duque III, Health Undersecretary Maria Rosario Singh-Vergeire, and Vaccine Czar and Inter-agency Taskforce (IATF) Chief Implementer Sec. Carlito G. Galvez.

According to Usec. Singh-Vergeire, it is important for the public to be informed of the progress of the country's active plan in acquiring and deploying vaccines as soon as a safe and effective COVID-19 vaccine becomes available for the public. (From page 1) quarrying sites which operate at the same river that there were casualties, the environment chief said.



According to Cimata, the temporary shut down of the identified quarry sites will give time to the composite team to review the compliance of the operators on quarrying regulations.

The Revised Implementing Rules and Regulations of the Philippine Mining Act of 1995, the PCRMIB must be formed to "accept, process, and evaluate applications and determine administrative charges and fees for Quarry, Sand and Gravel, Guano, Gemstone Gathering, and Small-Scale Mining Permits duly filed."

Retrieval operations are ongoing in the building extension of the Polytechnic Mfg. Inc. in Langkaan I, Dasmariñas, Cavite. Several construction workers who are staying at the back of the building were buried due to the collapsed back part of the building with an approximate height of 50 feet. Based on reports, the building collapsed at 5 a.m. Body of a certain Jomer Blesario was retrieved 10:32 am by the CDRRAMO headed by Reynor Cataño with the help and support

of Brgy. Officials headed by BC Laudato, Fire Department headed by Col. Alienza with the assistance of PNP Dasmariñas headed by COP Richard Ang. He was brought to the Pag-aman ng Dasmariñas and is now out of danger. Cong. Pidi Barza-ga will be going back to the Provincial City Regulatory Mining Board (PCRMIB), manages quarrying operations in the provinces. "All quarrying in the provinces is being managed by the regulatory board there composed of DENR, local government isang anak na 2 years old at dimala sa Pagmamatuag ng Dasmariñas para sa formal declaration ng death of the contractor together with the representative of Polytechnic Mfg., Inc.
