DILG sisimulan na ang recruitment ng 50,000 contact tracers

Sisimulan ng Department of the Interior and Local Government (DILG) ang recruitment, hiring, at pagsasanay ng hindi bababa sa 50,000 mga contact tracers sa buong bansa upang mapal-akas ang contact tracing program ng bansa kasunod ng paglagda ng Pangulo "Bayanihan to Recover as One Act" o Bayanihan 2 Law.

Sinabi ni DILG Secretary Eduardo M. Año na ang karagdagang 50,000 contact tracers ay "game-changer sa COVID-response ng ban-

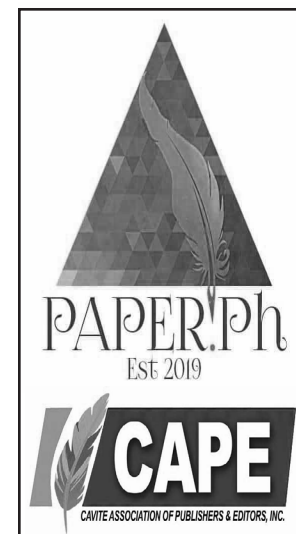
sa dahil mapipigilan ang paglaganap ng sakit at mapupuksa na ang COVID-19 sa kalaunan."

"Malugod naming tinatanggap ang paglagda ng Bayanihan Law 2 sa-pagkat nangangahulugan ito na maaari na nating simulan ang proseso ng pagrecruit ng mga karagdagang contact tracers na agarang kailangan ng iba't ibang mga Local Government Units sa buong bansa. Muli, pinasasalamat namin ang Pangulo at Kongreso sa paglalaan ng kinakailangang pondo para sa COVID response,"

Si Sinabi niya na ang 50,000 contact tracer na kukunin ay itatalaga sa iba't ibang mga Contact Tracing Teams (CTT) ng Local Government Units. Sa kasalukuyan, ang mga Contact Tracing Teams ay mga pinagsamang yunit na pinamumunuan ng mga Municipal/City Health Officers na may mga kasapi mula sa Philippine National Police, Bureau of Fire Protection, Barangay Health Emergency Response Teams (BHERTS), at mga volunteers mula sa mga Civil Society Organizations (CSOs).

Sa kasalukuyan, mayroong 97,400 contact tracers sa buong bansa at sa tulong ng karagdagang contact tracers ay na maaabot ang pambansang target na 150,000 contact tracers. "Sa karagdagang 50,000 contact tracers, masusunod na natin ngayon ang Magalong formula ng pag-trace sa 37 close contacts sa 1 pasyente ng COVID hanggang sa ikatlong degree," aniya.

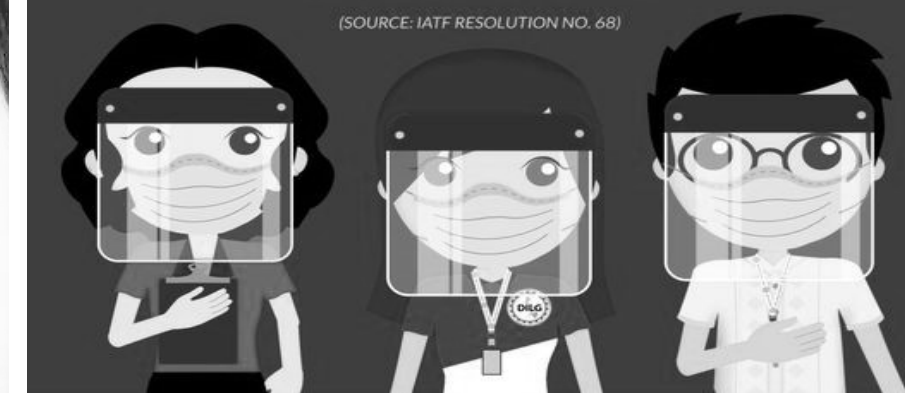

Round 2 of Sabayang Patak Kontra Polio initiated by DOH

Last July and August 2020, DOH in partnership with the Local Government Units (LGUs) conducted the first round of SPKP in the same regions. The results, however, were below the desired target of 95% vaccination coverage of children under five years of age — 80.6% (Phase 1) and 81.39% (Phase 2) in Region III, and 81.71% (Phase 1) and 70.88% (Phase 2) in the three provinces of Region IVA. "With the COVID-19 pandemic, the challenges in conducting an effective polio outbreak response immunization are numerous and unprecedented. Nevertheless, our health workers and vaccinators have worked tirelessly to reach every child and provide them with oral polio drops. The oral polio drops will provide additional protection to our children against the poliovirus and prevent the spread of the

polio outbreak," Health Secretary Francisco T. Duque III remarked. The SPKP is a series of polio vaccination rounds provided to children under 5 years of age in selected high-risk areas of the country, where each vaccination round is synchronously conducted within a two-week period. Since July of 2019, the Department has successfully conducted several rounds of SPKP in the National Capital Region and in all regions of Mindanao. This year, the Department included additional two regions, namely Regions III and IVA, after polio cases were reported in Cabanatuan City, Nueva Ecija, and Calamba City, Laguna. "I challenge our Central Luzon and CALABARZON Centers for Health Development and LGUs to replicate the successes and best practices of our previous SPKP campaigns. The outcome of this SPKP round will determine our next steps in addressing the polio outbreak," Secretary Duque said. Poliomyelitis is a disease with devastating and lifelong consequences such as paralysis or even death. There is no cure for the disease and vaccination is the best way to prevent polio. "Our fight against polio is not over. Since the mOPV2 is not commercially available and only given in government health facilities, I continue to urge parents and caregivers to have their children vaccinated against this disease during the said vaccination dates. Let us work together and ensure that no child is left behind unvaccinated," the Health Secretary concluded. Source: DOH

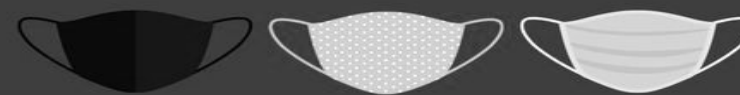

(From page 3) spying or hacking the social media posts as evidence when s/he has already committed a violation. May violation ka

na nga, pinangalandakan pa sa social media," he added.

Among the most common quarantine violations flaunted on social media are mass gathering and celebrations, drinking session, non-observance of physical distancing, non-wearing of face masks, and pillion riding on motorcycles of unauthorized individuals.

Malaya advised that netizens should be cautious, maintain their privacy, and that they should exercise sound discretion regarding how much personal information they are willing to show on their social media pages.

"Netizens ought to be aware that, by entering or uploading any kind of data or information online, they are automatically and inevitably making it permanently available online, the perpetuation of which is outside the ambit of their control. Since these are public posts, the PNP has every right to make social media posts as a basis to begin an investigation if warranted," said Malaya.

Also, he stressed, unscrupulous and ill-intentioned hackers may infiltrate their pages and steal information which they might use in any way they want. Source: DILG

DILG and JTF COVID Shield agrees to online reporting of quarantine violators

The Department of the Interior and Local Government (DILG) welcomed and defended the move of the Joint Task Force COVID Shield, inviting netizens to report violations of quarantine protocols through its official Facebook page and for the PNP to monitor quarantine violations through social media.

DILG Secretary Eduardo M. Año commended the move saying that "it encourages citizen engagement through social media platforms and it appeals to all civic-minded young people who are concerned about the health and welfare of all Filipinos."

"Now that we have flattened the COVID-19 curve, all the more should we be more careful and vigilant so as to contain and further reduce the active cases. Habang hinihintay natin ang pagdating ng bakuna, mas lalo nating pag-ibayuhin ang pag-iingat and enforcement of minimum health standards," Año said.

The PNP's JTF COVID Shield earlier ordered all police stations and units to monitor social media platforms for possible quarantine violations.

Netizens were also encouraged by JTF COVID Shield Commander Gen. Guillermo Eleazar to tag the JTF FB page when they see photos and reports online of violations of minimum health standards and other quarantine violations.

DILG Undersecretary and Spokesperson Jonathan Malaya belied criticisms that the use of Facebook or social media to investigate quarantine violations violates the right to privacy of the individual saying that there is no violation of the right to privacy when it is the person himself who

individual himself that posted it online.

"We cannot afford protection to persons if they themselves did nothing to place the matter within the confines of their private zone," he said.

Citing the Supreme Court ruling in *Vivares vs St Theresa's College* wherein some students who posted nearly nude photos on social media were not allowed to join their batch's graduation ceremony, Malaya said that there is no violation of the right to privacy when it is the person himself who
