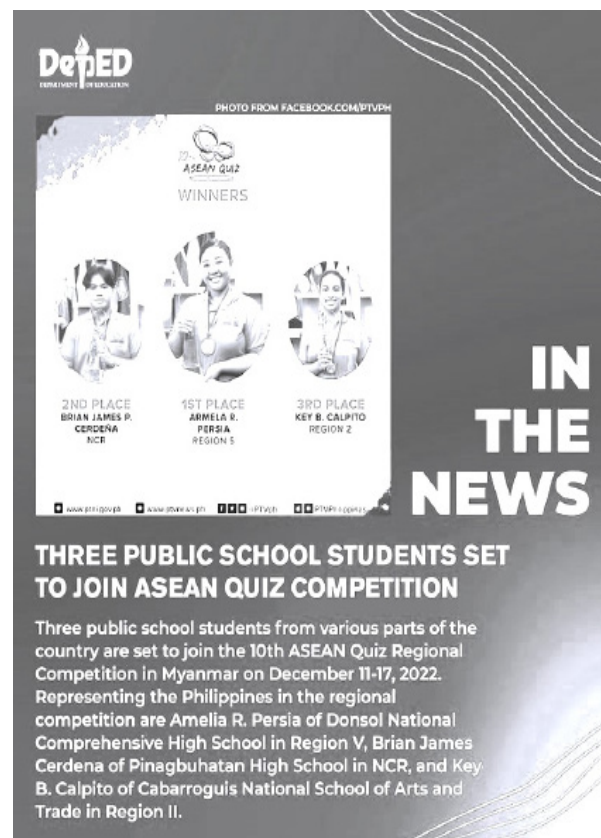


3 public school students to join ASEAN competition

Three public school students from various parts of the country are set to join the 10th ASEAN Quiz Regional Competition in Myanmar on December 11-17, 2022.

Representing the Philippines in the regional competition are Amelia R. Persia of Donsol National Comprehensive High School in Region V, Brian James Cerdena of Pinagbuhatan High School in NCR, and Key B. Calpito of Cabarroguis National School of Arts and Trade in Region II.

The students were the top three winners in the recent 10th ASEAN Quiz National Competition that was participated in by 17 Grades 9-10 students from the country's 17 administrative regions. The national competition was held at PTV Broadcast Center in Quezon City last May 17-20, 2022.



Furthermore, the land, Lao PDR, and Singapore. The ASEAN Quiz, which started as a project of the ASEAN Committee in Culture and Information (COCI) in 2002, is a bi-annual competition participated in by students of public and private secondary schools from the 10 ASEAN Member States.

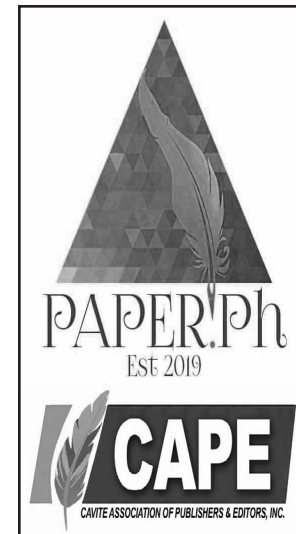

611 former rebels and families receive over P45-M E-CLIP assistance

Some 611 former rebels and their families received a total of P45.79-million in financial and livelihood assistance since July 2022 under the government's Enhanced Comprehensive Local Integration Program (E-CLIP) to help them lead peaceful lives, according to the Department of the Interior and Local Government (DILG).

DILG Secretary Benjamin "Benhur" C. Abalos, Jr. said the assistance granted to covers livelihood, housing, medical and other social services cru-

cial to their reintegration into society. "Wars are won by the hearts of the people. We need to reframe our focus on viewing insurgency as purely security and mili-

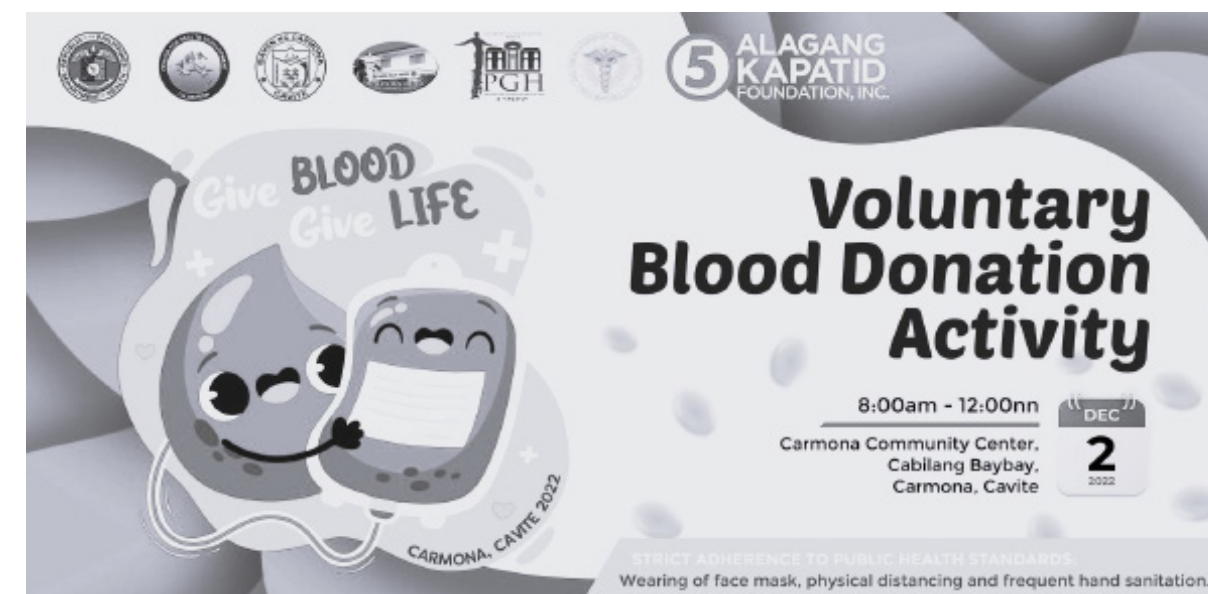
tary concern into a much broader social, economic Pampanga held recently. He urged local government units (LGUs) to work closely with the national government in nip-ping insurgency from the roots by prioritizing pro-grams, projects and activi-ties that are responsive, socially inclusive, and in-volve the active participa-tion of different sectors to pursue the country's peace agenda.

He cited the institu-tionalization of the whole-of-nation approach in Exe-cutive Order No. 70 as the game changer in address-ing the ills of the society including poverty, social inequality, and historical injustice among others.

from 89 down to five (5) and that some 3,207 geographically isolated and disadvantaged areas (GIDA) have completed the capacity development initiatives of the Retooled Community Support Program (RCSP). Despite the huge budget cut in the SBDP FY2022 budget from P20-million to only P4-million per barangay, Abalos assured the LGUs that the DILG and Pres. Ferdinand Marcos, Jr. are one with the LGUs in ensuring that all the barangays, cities, municipalities, and provinces institutionalize the peace agenda in their plans and pursue pro-

grams and activities that will help facilitate the responsive delivery of basic services. Showcase of best practices Meanwhile, DILG Undersecretary for Local Government Marlo Iringan said the SBDP Summit goes back to the whole-of-nation approach in the Executive Order No. 70 being the foundation for the crafting of the Department's peace projects. "We have journeyed and worked together to foster localized peace engagement and opened up livelihood opportunities. Let us celebrate the gains achieved over the years, share the good news, be

more inspired and motivated to give more. Let us ensure vertical linkage of the communities to the national peace agenda," Iringan said. DILG III Region Director Atty. Anthony Nuyda said the SBDP addresses the problem of inequality as funds as now available for development projects even in far-flung areas. "May we all go back to our constituents full of enthusiasm. Let us lead our constituents towards peace and development," Nuyda said.

The SBDP Summit was organized by the DILG Localization of Executive Order No 70 (LEO 70) Project Management Office (PMO),(SBDP PMO, and DILG Region III. DILG and DOH to award PinasLAKAS LGU champions

Local government units (LGUs) which have fared well in the government's COVID-19 vaccination and booster campaign will be recognized as PinasLakas LGU Champions following the signing of a joint memorandum circular between the Department of the Interior and Local Government (DILG) and the Department of Health (DOH) recently. The DOH-DILG Joint Memorandum Circular 2022-01 on the awarding and recognition of PinasLakas LGU Champions aims to fete top-performing LGUs for their significant efforts in the implementation and success of the government's PinasLakas campaign, recognize their best practices, and inspire others to follow suit. The JMC was signed by DILG Secretary Benjamin 'Benhur' C. Abalos, Jr. and DOH Officer-in-Charge Dr. Maria Rosario S. Vergere. "Mula pa sa umpisang ay nakita na natin ang sipag at dedikasyon ng LGUs sa PinasLakas campaign. It

is, therefore, fitting to give tribute to the LGUs who have performed excellently in the campaign and have been instrumental in building a solid wall of immunity against COVID-19 in their localities," Abalos said. The PinasLakas campaign was launched by the DOH with the support of the DILG and other agencies and stakeholders to support the implementation of Republic Act (RA) No. 11525 or the COVID-19 Vaccination Program Act of 2021 and the directives of President Ferdinand R. Marcos, Jr. According to Abalos, LGUs will be assessed based on the following criteria: increase of vaccination accomplishment from the baseline data for the A2 or senior citizens category, and the final 1st dose booster coverage (60 points); complete and timely submission of vaccination accomplishment through the Vaccine Administration System Line List (20 points); establishment of at least one vaccination site for each

of the DOH-proposed settings-based vaccination site (10 points); and established partnership with stakeholders and private sector for demand generation and communications (10 points). He said the assessment shall cover all cities and municipalities nationwide, including those in the Bangsamoro Autonomous Region in Muslim Mindanao. Performance indicators are likewise adjusted according to the following categories: highly-urbanized cities; independent component cities and component cities; first to third class municipalities; and fourth to sixth class municipalities. He said LGUs will be assessed for their accomplishments within the period of July 26, 2022 to October 9, 2022, following the First 100 Days directive of President Marcos. "Only the official vaccination data submitted to the DOH as reported by its appropriate units will be used as basis for assessing the LGUs and determining the PinasLakas LGU champions," he said. Based on their ratings, LGUs garnering 90 points and above will be awarded as first placers; LGUs with 85-89 points will be ranked second; and LGUs with 80-84 points will be ranked third. Likewise, Abalos said special recognition will be given to LGUs that have reached 90 percent coverage or above for the A2 population before July 26, 2022. Said LGUs shall also qualify as PinasLakas LGU Champions. Source: DILG
